As per the letter no. Edu/PD/SmS/2901-04/21, dated 27-08-2021 of Directorate of Samagra Shiksha UT of J&K, Jammu, regarding opening of online portal for submission of course fee by D.El.Ed teacher trainees of 2nd batch (2017 2<sup>nd</sup> year) of UT of J&K and UT of Ladakh where it has been requested that the students may pay the 2<sup>nd</sup> year admission fees directly to NIOS through online as the Govt. of J&K is not having sufficient funds.

The programme got delayed due to various administrative reasons including the first year activities due to pandemic and lockdown .

In order to conclude the programme with respect to mandatory requirement of the programme & as per request of Directorate of Samagra Shiksha UT of J&K, the Schedule for Registration & Payment for admission of second year (2<sup>nd</sup> batch) of 2787 trainees of D.El.Ed Offline session 2017-19 for the State of J&K only is open as per the Schedule as under:

The admission fee is to be paid through the online mode only within the stipulated time. No offline fee will be accepted.
