As per the letter first cited, the Regional Director, Regional Centre, National Institute of Open Schooling, MHRD, Government of India, Kochi has requested for recognising Secondary/Senior Secondary Certificates issued by NIOS as equivalent to the Certificates issued by respective State Boards. Government have examined the matter in detail and are pleased to recognise the Secondary/Senior Secondary Examination Certificates issued by National Institute of Open Schooling as equivalent to the Certificates issued by the Secondary/Higher Secondary Boards of State of Kerala respectively subject to the following conditions:

- i) In the case of Secondary Education, the candidates of NIOS should have studied two languages, Social Science/ Psycology, Science and Mathematics and should have obtained a grade not below D+ (30% score) for each subject.
- ii) One of the two languages at the Secondary level should be Malayalam.

 This condition is applicable to those candidates registering for Secondary Education from the academic year 2011-12 onwards.
- iii) In the case of Senior Secondary Education; the candidates of NIOS should have studied two languages and three optional subjects and should have obtained a grade not below D+ (30% score) for each subject.

iv) the candidates should have completed the age of 18 years for the Senior Secondary level and 16 years for the Secondary level as on Ist June of the year of
