As you are aware that the addendum to the notification no. 37/2021 was issued by Vocational Education Department on 13.09.2022 regarding Vocational subject integrated with Academic courses (Secondary and Senior Secondary) does not have TMA. Instead the marks of Internal Assessment are to be awarded by the AI's for vocational courses mentioned in table below.

For Vocational Education courses, there are three components for assessment i.e. Theory Practical and Internal Assessment as per scheme of examination given in the Vocational Education Prospectus.
