

## NOTIFICATION: 45/2023

The next Public Examination of NIOS for Secondary and Senior Secondary courses is scheduled to be conducted during **October-November 2023**. The schedule for registration and payment of examination fee for Secondary and Senior Secondary courses is as under:

WITHOUT LATE FEE		
1.	For learners enrolled in <b>Stream-I, Block-II</b> for <b>October-November 2023</b> Examinations	21 <sup>st</sup> May, 2023 to 20 <sup>th</sup> June 2023
2.	For eligible learners for examinations prior to <b>April-May 2023</b> Examinations	
WITH LATE FEE OF Rs. 100/- PER SUBJECT		
3.	For all eligible learners as mentioned at Sl. no. 1 and 2 above	21 <sup>st</sup> June, 2023 to 30 <sup>th</sup> June, 2023
WITH CONSOLIDATED LATE FEE OF Rs. 1500/- PER LEARNER		
4.	For all eligible learners as mentioned at Sl. No. 1 and 2 above	01 <sup>st</sup> July, 2023 to 10 <sup>th</sup> July, 2023
For the learners registered for April-May 2023 examinations, the examination fee payment schedule will be notified after the declaration of result.		

The learners of Senior Secondary Course must ensure compulsory gap of two years from the block/session and year of passing the Secondary examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming October-November 2023 examinations. The learners may therefore carefully select the subject(s) accordingly to appear in the examinations. The requisite examination fee is to be paid only through online mode by visiting NIOS website: <http://sdmis.nios.ac.in>.
