## Notification - 25/2023

In pursuance to the recommendations of the committee and subsequent approval of the Competent Authority NIOS, the scheme of integration of vocational courses with academic subjects has been revised. The revised scheme of integration of vocational courses with academic subjects will be implemented from Academic Session 2023-24, Stream 1, Block 2 (registration starting from 16th September 2023). The revised scheme is as follows:

1. The following vocational courses will ONLY be offered in integration with academic subjects at Accredited Institutes (AIs):

Secondary Level			Senior Secondary Level

- 2. The integration scheme being offered at Accredited Vocational Institutes (AVIs) is withdrawn.
- 3. The assessment criteria for the subject/ courses under integration will be same as those for academic subjects. Hence, to pass in a subject, a learner needs to secure a minimum 33% aggregate (Theory plus Practical) and 33 marks out of 100 is required after including the Internal Assessment marks in the aggregate of theory plus practical at secondary level. However, passing separately in Theory and Practical with minimum 33% each and min. 33% in aggregate including Internal Assessment is necessary to pass in a subject at senior Secondary level. This scheme of passing criteria in the integrated vocational subjects shall be implemented from Oct/Nov 2023 exams.
- 4. The vocational courses/ subjects under scheme of integration would not be offered as independent vocational certificate programme from vocational admission cycle- Block II, 2023. Therefore, these courses are being withdrawn from the list of independent vocational certificate programmes from vocational admission cycle- Block II, 2023.
