Sir/Madam,

On behalf of National Institute of Open Schooling, Regional Centre Ranchi, sealed Quotations (sealed in double cover) are hereby invited for lifting of above items for pulping, as per Annexure-I along with an earnest money of Rs.20,000/- (Rupees twenty Thousand only) on the following terms and conditions.

TERMS AND CONDITIONS:

- 1. The highest rates accepted for pulping will be valid up to 27.03.2024. The term can be extended further only on receiving written consent from the firm/ tenderer.
- 2. The physical inspection of above items, quantity etc. to be lifted for pulping can be made available to the interested parties from Monday to Saturday between 10.00 AM and 5.00 PM at the **Regional Centre, Ranchi.**
- 3. The Earnest Money of Rs.20,000/- (Rupees twenty Thousand only) should be deposited by way of Bank Draft drawn in favour of the **Secretary, NIOS, Payable at Ranchi** along with the Sealed Quotation as per Annexure-I, without which the quotations will not be considered.
- 4. The sealed Quotation alongwith requisite EMD duly sealed in double cover should be dropped in the Box available at the Main Entrance of the National Institute of Open Schooling, Regional Centre, Ranchi by 21.03.2024 up to 5.00 PM.
- 5. Opening of sealed Quotation will take place on 22.03.2024 at 3.00 PM in the NIOS Regional Centre in the presence of the representative of the firms/ tenderers, who may wish to be present at that time. No separate intimation thereof will be sent/ to the firms/ tenderers in this regard.
- 6. Amongst the tenderers the highest rate quoted against each group will be considered for acceptance.
- 7. The firm(s) whose highest rates offer is accepted will have to deposit 90% of the estimated cost of the item(s) to be lifted to the Regional Director, National Institute of Open Schooling, Ranchi by way of Bank Draft drawn in favour of the Secretary, NIOS, payable at Ranchi prior to lifting of the item(s) for pulping.

- 8. The firm(s) will have to fix the date and time of lifting of waste material with the authorized committee of the National Institute of Open Schooling. Lifting of waste material will be allowed in the presence of the Committee.
- 9. For weight of the goods/item(s) the facilities of Dharma Kanta available nearby to Regional Centre should be used. The payment for this purpose will be made by the firm(s).
- 10. Prior to weight of the materials, the weight of the vehicle in which the goods will be loaded is required to be carried out.
- 11. Earnest Money Deposit as well as 90% estimated cost of goods deposited by the firm(s) to National Institute of Open Schooling will be liable to be forfeited, if the materials are not lifted by the firm as per the schedule fixed by the authorized Committee of National Institute of Open Schooling.
- 12. No labour or labour charges for loading-unloading of the goods required to be lifted, will be provided by National Institute of Open Schooling.
- 13. A Certificate in respect of re-pulping of papers is to be submitted by the agency within 15 days of lifting the materials to the Regional Director, NIOS, Regional Centre, Ranchi.
- 14. National Institute of Open Schooling reserves the right to reject any or all the Tenders/ Quotations without assigning any reason thereof.
- 15. The firm (s) will have to lift the goods irrespective of the quantity of goods available, which may be small or huge.
- 16. For any dispute, if arises, an Arbitrator will be appointed by the NIOS competent authority, whose decision will be final. The court's jurisdiction for any dispute will be at Ranchi.
