The examination fee is Rs.400/- per subject/Module (Inclusive for theory, practical and internal assessment if any).

The Schedule for registration and payment of examination fee is as under:

Sl No	Fee Schedule	
1.	For all eligible learners	11 th August, 2025 to 25 th August, 2025 (without late fee)
2.	For all eligible learners with late fee of Rs. 150/- per subject	26 th August, 2025 to 30 th August, 2025 (with late fee)
3.	For all eligible learners with consolidated late fee of Rs. 1600/- per learners	31 st August, 2025 to 04 th September, 2025 (with consolidated late fee)

The examination fee payment schedule for the learners registered for April-May, 2025 examination will be notified after the declaration of result, in case result is not declared before 11th August, 2025.

All the Regional Directors are to note for compliance and also directed to intimate to the concerned AVIs for submission of Examination Fee of Vocational Education Courses within the stipulated time.
