In continuation to the Notification No. 26 dated 22nd May, 2025 regarding submission of exam fee for public examination of NIOS Secondary and Senior Secondary Courses **October/November**, 2025 the schedule for registration and fee collection for all **registered learners of April/May**, 2025 Examination is as under:

3.		With consolidated late fee of Rs. 1600/- per learner	05 August 2025 to 11 August 2025

The learners of Senior Secondary Course must ensure compulsory gap of two years from the Block/Session and year of passing the Secondary Examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming **October/November**, 2025 Examinations. The learners may therefore carefully select the subject(s) accordingly to register for the examinations. The requisite examination fee is to be paid only through online mode by visiting NIOS website: sdmis.nios.ac.in.
