The exam centres shall be fixed at KendriyaVidyalayas, NavodayaVidyalayas, Government/ Govt. aided / Private Schools / Colleges /Institutionsaffiliated with CBSE/ICSE/State Boards/ Universities as per the exam Bye-laws of NIOS.

In view of this, Regional Directors are to make concerted efforts to motivate the Principals/Heads of the Schools /Collegesunder their region to apply online for examination centres of NIOS. The URL for exam centre registration is https://exams.nios.ac.in. The norms for the exam centre are available on the NIOS website. The Bank undertaking Performa has to be filled up and to be uploaded at the given link. The original Centre Acceptance form along with the Bankundertaking complete in all aspectsis required to be submitted immediately to the concerned Regional Centre of NIOS. The portal will remain openfor online submission of applicationfrom 11.06.2025 to 10.07.2025.

The Schools/Colleges already registered previously have to give their consent only for this exam with updating the details (if any) and Bank undertaking.

The examination centres shall be fixed by NIOS as per the exiting norms at the time of fixation and does not give any right or priority to any schools/institutions at this stage.
