The learners of Senior Secondary Course must ensure compulsory gap of two years from the block/session and year of passing the Secondary examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming **October-November 2025** examinations. The learners may therefore carefully select the subject(s) accordingly to appear in the examinations.
